ELIGIBILITY CRITERIA

- 1. Only those candidates are eligible to provide consent who:
- i. Applied for admission to private sector medical and dental colleges through the UHS online application portal within the prescribed deadline under the centralized admission policy.
- ii. Were selected on a merit-cum-preference basis in any of the selection lists of MBBS/BDS for private sector medical/dental colleges but failed to submit the requisite fee within the stipulated time and, therefore, excluded from the admission process.
- Candidates who are already admitted to any public or private sector medical/dental college are not eligible to apply for these vacant seats.
- 3. Admissions will be granted strictly on the basis of merit, college preferences, and availability of seats. Candidates shall only be considered for colleges where the closing merit in the regular selection lists corresponds to their merit position. Under no circumstances shall a candidate be admitted to a college where the cut-off merit is higher than his/her merit.
- 4. The process of filling vacant seats shall not impact candidates who have already secured admission.

ADMISSION PROCEDURE

1. Eligible candidates must submit their consent separately for MBBS and/or BDS for admission through the following links:

No application fee is required for the consent. The above consent links have been activate				

- The portals shall be activated exclusively to collect consent from existing applicants who were selected in previous selection lists but did not join within the prescribed deadline. No new applications shall be entertained.
- 4. Candidates must provide a fresh Order of Preference for the medical and/or dental colleges with available vacancies. Once submitted, the preferences shall be considered final and cannot be modified after the submission deadline.
- 5. Candidates who have previously applied for admission to the MBBS program may give their consent to be considered for BDS, and vice versa, provided they meet the merit criteria specified above.


