HOW TO APPLY:

- 1) Applicants are required to apply online through university job portal (<http://portals.uhs.edu.pk/jobs>). The applicants are also required to submit signed hardcopy/printout of the same pre-filled online application form to the Office of Deputy Registrar (HR), Room # 12, University of Health Sciences, Khayaban-e-Jamia Punjab, Lahore. Fill online application form carefully as no editing will be allowed after submission.
- 2) The applicants are required to print system generated fee challan and deposit job application processing fee as mentioned on challan through 1Link or in any branch of Bank of Punjab.
- 3) The applicants are required to attach and submit attested copies of CNIC, domicile, all educational documents/certificates, experience certificates and any other relevant documents along-with deposited system generated fee challan as per the following approved rates on or before the closing date:
 - a) BPS-17 & Above = **Rs. 2000/-**
- 4) Applications submitted without deposited system generated fee challan will not be entertained. Deposited amount is non-refundable/non-transferable.
- 5) Closing date for submission of online applications is 16-02-2026 within office hours. Printed online application form along-with all attach documents must be submitted in person or via courier. Incomplete application or applications received after due date will not be accepted.

IMPORTANT

- 6) Only Punjab domiciled candidates can apply.
- 7) The applicants are required to submit PM&DC Experience Recognition Certificates corroborating with the positions they are applying for. In case the recognition certificate is in process then the evidence of submission will be required.
- 8) The applicants in possession of Experience Certificates issued by University of Health Sciences or any other approved institution are required to get their certificates verified from PM&DC. In case the verification of recognition certificate is in process then the evidence of submission will be required.
- 9) University shall determine the relevancy of Research Publication to specialty of applicants.
- 10) University may conduct a subject test in case the ratio of the post to the eligible applicants is more than 1:5.

- 11) Those having foreign qualifications are required to submit equivalence certificate issued by Higher Education Commission, Pakistan / Pakistan Medical & Dental Council (PM&DC).
- 12) Appointments will be on contract basis as per UHS Service Statutes 2005.
- 13) Preference will be given to those having experience in a reputable Public Sector Medical University / Institution.
- 14) Relaxation in upper age limit may be granted to suitable candidates as per statutes / rules of Government of Punjab.
- 15) The selected candidates can be posted at any campus of the University (City & Jinnah Campus KSK).
- 16) Incomplete applications or applications received after due date will not be entertained.
- 17) University reserves the rights to increase/decrease or totally withdraw the vacancies without assigning any reason.
- 18) Applicants working in Public Sector Organization / Department must apply through proper channel.
- 19) No TA/DA shall be admissible.
