Admissions Against Vacant BDS Seats in Private Sector Dental Colleges of Punjab Session 2024-25

This is with reference to the advertisement (SPL # 570) published in national newspapers on March 29, 2025.

In compliance with the decision of the Provincial Admission Committee in its meeting held on April 10, 2025, the University of Health Sciences (UHS), Lahore, hereby invites consent from non-joining candidates of the previous selection lists of BDS for the Session 2024-25 for admission against vacant seats in the following private sector dental colleges:

ELIGIBILITY CRITERIA

- Only those candidates are eligible to provide consent who:
 - Applied for admission to private sector dental colleges through the UHS online application portal within the prescribed deadline under the centralized admission policy.
 - Were selected on a merit-cum-preference basis in any of the selection lists of BDS for private sector dental colleges but failed to submit the requisite fee within the stipulated time and, therefore, excluded from the admission process.
- Candidates who are already admitted to any public or private sector medical/dental college are not eligible to apply for these vacant seats.
- Admissions will be granted strictly on the basis of merit, college preferences, and availability of seats. Candidates shall only be considered for colleges where the closing merit in the regular selection lists corresponds to their merit position. Under no circumstances shall a candidate be admitted to a college where the cut-off merit is higher than his/her merit.
- The process of filling vacant seats shall not impact candidates who have already secured admission.

ADMISSION PROCEDURE:

- Eligible candidates must submit their consent for admission through the following link: <http://forms.uhs.edu.pk/privatevacantseatsconsent> No additional application fee is required.
- The portal shall be activated exclusively to collect consent from existing applicants who were selected in previous merit lists but did not join within the prescribed deadline. No new applications shall be entertained.

- Candidates must provide a fresh Order of Preference for the dental colleges with available vacancies. Once submitted, the preferences shall be considered final and cannot be modified after the submission deadline.

IMPORTANT:

- Candidates who fail to submit their consent within the stipulated deadline shall forfeit their right to be considered for admission. No further opportunities for application shall be provided in this regard.
- In private sector medical colleges, any vacant seats shall be filled through upgradation in accordance with the Government of Punjab's Vacant Seat Policy.
