INTRODUCTION

Higher Education Commission (HEC) of Pakistan advised the universities and institutions to start semester system. It is suggested that all Higher Education Institutions must begin the process of converting to semester system and the process ought to be completed by spring 2017. It is highly recommended that the Higher Education Institutions should be able to bring their affiliated colleges to come at par with the semester system by 2017. (HEC 2015, 13.2).

BS Nursing curriculum designed by the HEC also reflects the semester wise break down of subjects and their credits. Shaukat Khanum Hospital and Research Centre is offering two-year BS Post-RN BS Oncology Nursing Degree program. The semester based curriculum of this program has been approved by PNC and UHS and the program is affiliated with UHS.

This document provides the statutes and regulations for examination of Post- RN BS Oncology Nursing Program. This includes the regulations related to internal assessment (conducted within the institute) and external assessment /examination (conducted by University of Health Sciences UHS).

SEMESTER DURATION

- a. There shall be two regular semesters (a Spring & a fall semester) in each academic year.
- b. Each semester shall be of 16-18 working weeks excluding final university examination. (HEC 2015, 1.3)
- c. There shall be 2 weeks for final (University) examination.
- d. There will be 2 weeks semester breaks at the end of each semester.

The institution may offer summer semester of 8 weeks during break as per the regulation given in by HEC 2015 5.1-5.4)

COURSE CREDITS

a. Minimum 60 credits are required for Post-RN BS two year's program. These credits shall normally be earned in four semesters. For Distribution of Credits see below. Post RN BS Oncology program has 64 credits which shall be earned over four semesters.

- b. One credit hour means teaching theory for one hour per week in each semester. (HEC 2015, 2.1)
- c. For practical/laboratory work, three hours shall be considered equivalent to one credit hour. (HEC 2015, 2.2)
- d. The credit hours are denoted by two digits within brackets with a hyphen/plus in between. The first digit represents the theory part while the second (right side) digit represents the practical.
- e. Thus 02 (1.5+0.5) means one and half credit hours of theory, while half credit a total of two credit hour is for laboratory/studio work/field work/practical work supervised and graded by the faculty.

PNC and UHS approved curriculum has maximum 64 credits for Post RN BS Nursing/ Oncology Nursing program.

As a course load, an undergraduate program of instruction generally includes a 15-18 credit hours course load including exams in a regular semester. The required course load for a full time undergraduate is minimum of 15 credit hours per semester. (HEC 2015, 6.1.1)

LEVEL OF PROGRAM: LEVEL 6.

After completion of level 5 qualification framework (SSC + three years general nursing and one year midwifery or any specialty courses) equal to associate BSc degree. Additional 2 years of post RN BSN equals level **6** undergraduate degree-Bachelor of Science in Nursing (HEC 2015)

ELIGIBILITY CRITERIA FOR ADMISSION:

a. Diploma in General Nursing & Midwifery (for females only) minimum 2nd division (Marks 55% and above) from an Institution recognized by Pakistan Nursing Council.

- d. At least 2 years' experience as a Registered Nurse of a well reputed health care organization
- e. Current Valid registration with Pakistan Nursing Council.
- f. Incomplete and late applications will not be processed.
- g. External candidates (applicants out of SKMCH&RC) will have to present no objection certificates (NOC) from the Head of the Deptt.

GENERAL REGULATIONS FOR EXAMINATION:

Internal Assessment and External Assessment Process

Academic progress of the students is made based on continuous internal assessment and external assessment. As per UHS rules, 20 % weightage for internal examination in semester courses whereas, 80% marks may be reserved for the examination conducted by the university.

Internal Assessment (20%) :

- In each semester, students may be required to appear in quizzes, midterms, final examination, give presentation, participate in group discussion, and submit projects/assignments/lab reports as determined by the teacher concerned.
- b. Nursing Division SKMCH&RC has a policy related to internal examination which is governed by the Selection and Progression Committee of the study program.

External Assessment (80%) :

- a. The Department of Examination of UHS will be responsible for to conduct end of semester exam after completion of every semester.
- b. A student who passes the internal assessment should only be allowed to appear in external exam conducted by UHS.
- c. Duration of end of semester examination shall be 2-3 hours. The final examination shall cover the entire course.
- d. To pass a course and semester, student must obtain CGPA 2.0.
- e. Rules for Promotion for Undergraduate Programs:
 - At the end of each semester, a student must obtain a minimum Grade Point Average (GPA) of 1.70 to be promoted to the next semester.
 - In case a student is unable to obtain GPA of 1.70, shall stand automatically dropped from the Registration.
- f. It is mandatory, as per PNC rules, for students to attend all courses, clinical sessions and examinations as scheduled.

A minimum of 85% attendance is essential in each of the scheduled classroom activities to be eligible to write any professional and notified examination and this will be strictly enforced. No compensations are possible.

- g. A student will not be allowed to take any examination, Internal/UHS exams, if his or her attendance in the relevant course is not satisfactorily completed.
- h. Absence for illness must be certified by the Employee Health Clinic at SKMCH&RC.
- i. Absence from internal examination will be considered as failure and will be awarded **zero score** and the candidate will not be allowed to sit in UHS examinations.
- j. One hundred percent (100%) attendance in clinical is expected of all students. Any student who misses clinical time is required to consult with course teacher/coordinator to negotiate remedial

strategies for meeting the clinical objectives. The student is expected to successfully complete all the clinical objectives to pass the clinical components of a course.

- k. A student who remains absent for 1 -2 days of clinical time for justified reasons (illness, death, marriage and emergency) after his or her resuming will be required to consult with the course teacher to negotiate remedial strategies to make up this clinical time and meet the missed clinical
- 1. There will be **no Supplementary**/ **Special Examination in a Semester System**; if a student fails in a course, he/s is required to repeat it. (HEC 2015, 11.3)
- m. An incomplete grade (I) will be awarded by the faculty only in exceptional cases beyond the control of a student such as serious accidents, family tragedy, serious health ailments, etc. (HEC 2015, 11.3).
- n. The candidate shall pass both internal and external examinations to pass the semester.

REPEATING COURSES:

- a. If a student gets 'F' grade, s/he will be required to repeat the course or its recommended alternate, if any. However, "F" grade obtained earlier will also be recorded on the transcript (HEC 2015, 9.1)
- b. Undergraduate students may be allowed to repeat a course in which s/he has obtained grade below "C" (HEC 2015, 9.2).
- c. The Institution may define maximum 3 subject in case of four semesters degree programs. (HEC 2015, 9.2).
- d. A course can be repeated only once in a regular semester.
- e. The student shall register for that course in the first week of semester, with the permission of the concerned teacher & approval of head of the institution.
- f. All attempts will be depicted on the transcripts. The highest grade only will be used for the calculation of CGPA. (HEC, 2015)
- g. In case of CGPA improvement, it would be recorded with (Imp) on the transcript. (HEC 2015, 9.4)
- h. All course repetitions must be completed within the maximum allowable duration of the programme. (HEC, 2015), which must be repeated within two semesters after the first attempt.
- i. The candidate shall have to pay the prescribed tuition fee for the course(s) he/she wishes to repeat. WITHDRAWAL:
- a. Students may be allowed to withdraw from a course during 4-6 week of the semester. In such a case the transcript shall record that the student enrolled in the course and withdrew. Consequently, grade W will be awarded to the student which shall have no impact on the calculation of the CGPA of the student. (HEC 2015, 8.4)
- b. A student withdrawing after the 6th week shall be automatically awarded "F" grade which shall count in the GPA and stay on the transcript. (HEC 2015, 8.5)

CHANGE OF COURSE(S)

There is no optional courses (s) in the PNC & UHS approved curriculum therefore; change of courses are not allowed in this degree program.

FREEZING OF A SEMESTER:

- a. Students are allowed to freeze the semester before the start of the academic session, if they have passed the final Examinations of previous semester with a minimum GPA/CGPA requirement. Nevertheless, the students are required to deposit the Tuition Fee of the semester / clear the fee requirements prior to requesting to freeze.
- b. Students have to resume their studies in the following year otherwise their name would be struck off the roll/registration.
- c. Students are not allowed to freeze two consecutive semesters. They are also not allowed to freeze more than two semesters in the total duration of the programe.
- d. Students are allowed to freeze the semester within the overall degree awarding timeframe (i.e. maximum time allowed for the completion of the degree (three years in case of Post RN BS Oncology Nursing).
- e. No freezing during the semester will be allowed. (HEC 2015, 23.1)
- f. If a student is not enrolled in any course in a semester, s/he will not be considered a regular student in that period. The student may then enroll in these courses in a subsequent semester; however, s/he will have to meet pre-requisites of any course taken.
- g. In special hardship cases, the institution/university may develop any criteria for freezing a semester with the prior permission of the Vice Chancellor. Medical certificate must be duly signed by the Institutional Employee Health Physician. (HEC 2015, 23.3)
- h. The duration of Freezing is one year; a candidate who gets a semester freeze can get readmission next year with upcoming session, but hardship cases can be considered by the competent authority only. (HEC 2015, 23.4)
- i. Freezing of first two semesters is not allowed in undergraduate BS programs (HEC 2015, 23.5)
- j. Under special hardship circumstances freezing of second semester can be considered by the approval of competent authority. (HEC 2015, 23.6)

Note: Freezing of Semester will only be allowed after successful completion of 1st Semester as prerequisite as the case may be for the other semester's predecessor to the freezing Semester.

ACADEMIC PROBATION (HEC 2015, 26)

Probation is a status granted to the student whose academic performance falls below the minimum University standard.

- a. The students acquiring less than 2.00/4.00 GPA in a semester but passing in all papers will be promoted with the condition to achieve more than 2.0 GPA in the next semester and s/he will be put on probation for the next semester.
- b. The students acquiring GPA 1.7 and above but failing in any paper(s) will be placed on probation and promoted to the next semester conditionally. They will have to be registered for summer semester to improve the grade if offered by the institution.
- c. Students acquiring GPA less than 1.7 in two consecutive semesters and failing in any paper(s) will be dropped from the program/university rolls. However, s/he will be eligible to seek re-admission. Re-admission will be allowed only once after the payment of full admission fee.
- d. Students on probation in two consecutive semesters even after attending Summer Semester in one academic year will take re-admission in that academic year once only.
- e. The student(s) who will not complete studies within stated periods including extension shall be struck off from the registration/rolls.
- f. It is also mandatory to obtain at least 50% marks in Practical, Projects, Thesis, Assignments, Test and Theory Paper separately/aggregate for individual course.

DURATION FOR COMPLETION:

- a. Maximum time period for the completion of PRN degree is three (3) years. (
- b. Further extendable for one year with the approval of Statutory Bodies of the university (HEC 2015, 1.3,)
