### **HOW TO APPLY:**

- 1) Applicants are required to apply online through university job portal (<http://portals.uhs.edu.pk/jobs> ). The applicants are also required to submit signed hardcopy/printout of the same pre-filled online application form to the Office of Deputy Registrar (HR), Room # 12, University of Health Sciences, Khayaban-e-Jamia Punjab, Lahore. Fill online application form carefully as no editing will be allowed after submission.
- 2) The applicants are required to print system generated fee challan and deposit job application processing fee as mentioned on challan through 1Link or in any branch of Bank of Punjab.
- 3) The applicants are required to attach and submit attested copies of CNIC, domicile, all educational documents/certificates, experience certificates and any other relevant documents along-with deposited system generated fee challan as per the following approved rates on or before the closing date:
  - a. BPS-17 & Above = **Rs. 2000/-**
  - b. BPS-14 = **Rs. 500/-**
- 4) Applications submitted without deposited system generated fee challan will not be entertained. Deposited amount is non-refundable/non-transferable.
- 5) Closing date for submission of online applications is **18.02.2026** within office hours. Printed online application form along-with all attach documents must be submitted in person or via courier. Incomplete application or applications received after due date will not be accepted.

### **IMPORTANT**

- 1) Only Punjab domiciled candidates can apply.
- 2) Appointments will be on contract basis as per UHS Service Statutes 2005.
- 3) Preference will be given to those having experience in a reputable Public Sector Medical University / Institution.
- 4) Experience, where prescribed, would include equivalent experience, in a profession or in the service of an autonomous body or semi-autonomous organization or well reputed private organization.
- 5) Relaxation in upper age limit may be granted to suitable candidates as per statutes / rules of Government of Punjab.
- 6) The selected candidates can be posted at any campus of the University (City & Jinnah Campus KSK).
